Nekkid Super Models

A title like “Nekkid Super Models” ought to get your attention, and we well know that a title like “Pre-Bid Protests and Post-Bid Protests” is a guaranteed snoozer. In January 2010 *Ditchmen* published an article about bid protests and specifically the 72 hour/10 day rule. It was a riveting subject, but some of you may have nodded off before finishing the article. So, for 2011, we have updated the subject and added lots of nekkid super models with the hope more people will read about bid protests. Ten minutes reading this article might enable you to win a contract in 2011 that you really need.

The majority of construction work currently being performed is in the public sector via the competitive bid process. Although nekkid super models have not yet started bidding for public contracts, we still have more contractors fighting for fewer contracts than we did a few years ago. (If nekkid super models start bidding for the work, at least the lettings will be entertaining for the 37 unsuccessful bidders seeking that “fat” \$50,000 manhole relining job.) Under the public contract competitive bid process, there are certain rules that are intended to ensure that the contract is awarded in a fair manner. For example, there are usually deadlines that must be met in order to preserve a bid protest. If you are the low bidder, are aware of the deadlines, and can keep your mind off of nekkid super models, then you might be able to defeat a protest by the second low bidder and keep your project. By the same token, if you are the second low bidder with legitimate grounds to protest but a deadline is

missed, then your protest cannot succeed. If you are a nekkid super model, you need to call my office and make an appointment to discuss this further.

The main thing to keep in mind regarding bid protests is that the protesting bidder must act as soon as the bidder becomes aware of the potential problem with the bid. If the bidder fails to put the owner on notice of the protest, then the bidder could lose its right to protest. The Florida Administrative Procedures Act (APA) governs bid protest procedures when the public owner is the State or a State agency, and the APA provides specific deadlines that must be followed whether protesting a bid prior to the letting or afterwards. The APA does not apply to municipalities and counties unless they have expressly adopted the APA bid protest procedures as their own. Nonetheless, even if a county or municipality has not expressly adopted the APA bid protest procedures, many of them have created their own bid protest procedures modeled after the APA. Thus, familiarity with the APA procedures is helpful and we will use the APA as the foundation for this discussion of bid protest procedures.

The APA addresses two types of protests: **Pre-bid protests**, and **post-bid protests**. Pre-bid protests are sometimes referred to as “specification protests”. When they think of a bid protest, most contractors think of a post-bid protest which takes place after the bids have been opened. The APA, however, also addresses pre-bid protests which must be filed before the bids are opened. For example, if prior to the opening of the bids, a

bidder becomes aware of a defect such as ambiguous specification, an improper requirement that equipment be obtained from a sole source, or perhaps an improper restriction regarding who may submit a bid, then the bidder is obligated to notify the owner of the defect prior to the letting.

Pre-bid protests must be filed prior to the letting so that the public owner has an opportunity to correct the problem. The APA states that when a potential bidder becomes aware of a problem prior to the bid, the bidder must notify the owner **within 72 hours** of receipt of the bid documents and then provide a formal written protest **within 10 days** of providing the notice of intent to protest. This is commonly referred to as **the 72 hour/10 day rule**. Failure to meet these deadlines can mean the right to protest is lost. The intent of the pre-bid protest procedures is to avoid wasting time on a defective letting. If the defect can be fixed prior to the letting, then that is the desired solution rather than waiting until the bids have been submitted. Unfortunately, many times by the time a bidder realizes that the specification is defective or bidder pool is overly restrictive, more than 72 hours has passed since the bid was advertised and the chance to protest has been lost. The staff you have assigned to look for potential projects to bid needs to be aware of the 72 hour/10 day rule, because it is those people who are in a position to catch the problem before it is too late.

The 72 hour notice of intent to protest can be as simple as a one

Efforts to Repeal Rule for Businesses to File 1099 For Small Vendor Transactions

Last month, we informed you about the controversial provision that was passed in the federal health care law in December 2010 which will greatly increase recordkeeping and forms processing for businesses. Starting in 2012, section 9006 of the Affordable Care Act will make two big changes: (1) payments businesses make to corporations will no longer be exempt from having to issue a 1099 and (2) the types of payments that will require a 1099 are significantly expanded. Basically, businesses will be required to issue 1099s on all payments to and purchases from any taxable entity, if the payment is more than \$600 in a calendar year. In January, both the House and

Senate have introduced legislation which would repeal the expanded Internal Revenue Service (IRS) Form 1099 reporting requirements included in last year's health care reform bill. All Republicans and most Democrats, including the president, support repealing the provision.

Senate Finance Committee Chairman Max Baucus (D – Montana) has introduced and pledged to pass a bill (S.72) repealing the expanded 1099 reporting requirements. A similar bill (S.18 entitled the "Small Business Paperwork Elimination Act of 2011") has been introduced by Senator Mike Johanns (R – Nebraska), but — unlike the Baucus bill — includes a deficit-neutral offset. The Johanns bill

already has 60 co-sponsors while the Baucus bill has 72 co-sponsors. A House version of the Johanns bill (H.R.4) has 271 co-sponsors but has not yet been scheduled for a vote. Businesses — especially small businesses — have been unanimous in their opposition to the new 1099 requirement.

Currently, businesses have to issue IRS Form 1099 on all unincorporated businesses for services over \$600. Under the new law, payments to corporations will no longer be exempt from reporting and will require a 1099 to be issued.

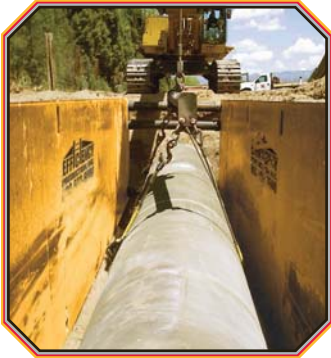

DBPR Licensing Process Better, Faster, Easier

DBPR continues to make the licensing process better, faster and easier. They have long been aware that moving the licensing process to an online environment would provide a better option for licensees, but until recently, a major impediment to moving the entire operation to an online system has been their inability to accept supporting documents electronically. DBPR took the necessary first step in upgrading their online services to fix this problem. They had been working with an outdated system, so the upgrade was very necessary and will, in time, become a huge improvement for customers. It will help DBPR achieve their mission of licensing efficiently and regulating fairly. It will be a good change.

It is, however, still a change. The upgraded system is new and a little different because it requires each customer to re-create their online profile, using their e-mail address as their new customer ID. After a new profile is created, the system automatically transfers all data associated with the old account (or multiple accounts) into the new profile. In addition to allowing DBPR to expand the number of things they can do electronically, the new system solves a problem that has plagued thousands of people who had licenses with them: it uses a customer's e-mail address as their online ID rather than the randomly generated number in the old system that was very difficult for people to remember.

Many people have found this upgrade process confusing, so DBPR staff updated the website with better instructions for the steps necessary to create the new account.

The system will also offer other significant benefits. Users can receive registration confirmation via e-mail and retrieve a forgotten password. You'll be able to get answers to eligibility questions to ensure you are using the correct application, and you'll be able to log in and finish an incomplete application if you weren't able to complete the application when initially applying. You'll be able to check your application status and

paragraph letter putting the owner on notice that you think there is a problem with the bid. Even if the owner fails to act on your notice, at least you have preserved your right and have gained an additional 10 days within which to evaluate the merits of the protest. The formal protest that is due in 10 days generally requires more effort than the notice of protest because it must specifically identify the facts and legal authority supporting the protest.

The APA also defines when a post-bid protest must be filed. The initial notice of intent to protest is to be delivered to the public owner within 72 hours of the owner's publication of the bid results and intent to award. Then, the APA states that the upset bidder must deliver a formal written protest within 10 days of the notice of intent to protest. Failure to meet either of these deadlines will mean the protest is waived. The

procedures governing a protest of a State contract are easy to identify, because the APA controls. But, what is a bidder to do if the owner is a municipality or county or some other public agency where the APA may not apply? A wise first move is for the bidder to simply call the

Registered Contractor License Renewal Reminder

Just a reminder that the Registered Contractor licenses from the Department of Business and Professional Regulation (DBPR) are up for renewal on August 31, 2011. Current law requires licenseholders to obtain 14 hours of continuing education with at least one hour in workplace safety, one hour in workers' compensation, one hour in business practices, one hour in the advance building code module, one hour in laws and rules (Chapter 489) and one hour in wind mitigation (this requirement only affects general, residential, building, roofing and glass and glazing contractors).

Don't forget to notify the DBPR office of any address change. Section 489.124(2) gives sole responsibility to the licensee for notifying DBPR in writing of the licensee's current mailing address and phone number.

Failure to notify the department of a change of address shall constitute a violation of this section. In addition, if your address changes and you do not notify the department, you may not receive important mailings from the department such as your renewal notice.

receive application summaries, and you'll be able to make payments and receive payment summaries.

Take a few minutes when you have time and create your new registration profile or, if you've already created a new profile, log in to the system and learn more about the different benefits it has to offer, like linking licenses to your account and maintaining license relationships. DBPR is available to answer any questions you might have along the way.

Division of Workers' Compensation Revises Workers' Compensation Notice Posters

The Division of Workers' Compensation recognizes the importance of providing stakeholders with more information to assist them in fulfilling their rights and responsibilities under the Workers' Compensation Law. As a result, the Division is pleased to announce three new enhancements that have been added to the **Proof of Coverage Database**. These enhancements will provide information relating to the number of employees reported for each employer; the governing classification code reported for each employer; and the scope of business or trade(s) listed on Certificates of Exemption. A detailed description of each enhancement is listed below:

1. **Total Number of Employees** – Represents the total number of employees for each employer as reported by the insurance carrier. The total number of employees is displayed for each location reported on the policy. Insurance carriers are required to report the total number of employees for all policies that are issued with an effective date of October 1, 2009 or after.

2. **Governing Classification Code** – Represents the workers' compensation classification code which best describes the business operation and which includes the most payroll generated by the business as reported by the insurance carrier.
3. **Scope of Business or Trade** – Refers to the trade or business activity that best describes the business as reported by the corporate officer. The scope of business or trades are displayed for each Certificate of Exemption. The Certificate of Exemption only applies to the scope of business or trade listed on the certificate.

Rule 69L-6.007, Compensation Notice, Florida Administrative Code, has been adopted and will become effective on January 30, 2011. The rule adopts the revised workers' compensation notice posters, including the Spanish version of the poster and updates the information that is required to be included on the poster. Section 440.40, F.S., requires every employer who has secured workers' compensation insurance to post in its place of business a workers' compensation notice and an Anti-Fraud Reward Program notice. Section 440.40, F.S., also authorizes the Department, by rule, to prescribe the form of the notices and to require carriers to provide the notices to policyholders.

For a transitional period of 90 days from the effective date of the rule, an insurer or self-insurance servicing agent may use the "broken arm" posters identified and adopted in subsection 69L-6.007(1), Florida Administrative Code, or the corresponding poster(s) in effect prior to the adoption of the rule. After the completion of the 90 day transitional period, only the revised posters adopted in this rule may be used.

person designated by the owner as the procurement officer/manager. The bidder should let the procurement official know that the bidder believes it has grounds to protest, ask what deadlines apply to preserve the protest, and where to obtain a written copy of the protest procedure. Then, immediately after the telephone conversation the bidder should send a letter to the procurement official via fax, e-mail, or hand delivery confirming the conversation. Once a copy of the actual protest procedure has been obtained, it must be read to determine and verify any deadlines that apply and the level of detail that must be included in the protest documents. If the protest procedure requires an initial notice of intent to protest, then the confirmatory letter might satisfy that requirement, but the specific rules need to be read to make sure because a second or third letter may be needed to preserve

the protest.

Some bid protest procedures require a protestor to post a bond to serve as security for the payment of any costs that are incurred by the owner in defending against a protest. For example, Section 287.042, Florida Statutes, requires that a protestor provide a bond equivalent to 1% of the proposed contract amount. Bidders should also be aware that if Section 255.20, Florida Statutes, applies, then a successful protestor may recover its costs as well as fees from the owner.

Most formal protest procedures, including those governed by the APA, provide for informal dispute resolution prior to institution of formal proceedings. The APA provides that within 7 days of receiving the formal protest, the government will meet with the protestor to see if a settlement can be negotiated. If settlement discussions are unsuccessful, then the matter is

referred to the Department of Administrative Hearings which will schedule and administer a bench trial before an Administrative Law Judge provided by the state.

A key element of the APA provides that upon receipt of a notice of intent to protest and absent exceptional circumstances, the letting is to be suspended until the dispute is resolved. Even absent a formal rule requiring that the letting be suspended, public owners will frequently suspend the letting in order to give the parties an opportunity to resolve the issue.

If the procuring government lacks any written bid protest procedures, then the protestor generally must file a law suit in the State Circuit Court asking a judge to order that the bid letting be stopped until the court determines whether the bid letting was improper.

Some bid protests are resolved

merely by informing the owner of the perceived problem. More often than not, however, the parties “lawyer up” in order to make sure that the competitive bid rules have been followed. Your lawyer cannot help you, however, if you have missed a deadline for preserving your protest. So, the first thing you need to do is to educate your estimators about the 72 hour/10 day rule. Then, if a potential protest is discovered you (or your lawyer) need to determine what deadlines apply and make sure those deadlines are met. It also wouldn’t hurt to bring some nekkid super models with you when you meet with your lawyer. We all know that nekkid super models go for pudgy, balding construction lawyers.

Public Works Contracts – New Requirement for a Certificate of Entitlement

Section 212.08(6), Florida Statutes (F.S.) and Rule 12A-1.094, Florida Administrative Code (F.A.C.), (Public Works Contracts), govern the taxability of transactions in which contractors and subcontractors purchase supplies and materials for use in public works contracts. Public works contracts are projects for public use or enjoyment, financed and owned by the government, in which private persons install tangible personal property that becomes a part of a public facility. The exemption in Section 212.08(6), F.S., is a general exemption for sales made directly to the government. Rule 12A-1.094, F.A.C., establishes the criteria that govern whether a governmental entity, rather than the public works contractor, is the purchaser of the materials.

Effective January 2, 2011, Section 8, Chapter 2010-138, Laws of Florida (L.O.F.), requires governmental entities (excluding the federal government) to issue a Certificate of Entitlement to each vendor and each contractor in order to purchase supplies and materials for use in public works contracts tax-exempt under Section 212.08(6), F.S. The Certificate of Entitlement certifies that: (1) the materials and supplies purchased will become part of a public facility; (2) the governmental entity will be liable for any tax, penalty, or interest due should the Department later determine that the items purchased do not qualify for exemption; and (3) the criteria established in Rule 12A-1.094, F.A.C., are being followed.

No changes are being made to the criteria established in Rule 12A-1.094(4)(b), F.A.C., to determine whether a governmental entity, rather than the public works contractor, is the purchaser of the materials. The purpose of the amendment to Rule 12A-1.094, F.A.C., is to: (1) maintain, without change, the current criteria governing whether a governmental entity is the purchaser of materials and supplies that qualify for exemption under Section 212.08(6), F.S.; (2) provide the requirements and format of the Certificate of Entitlement required by Section 8, Chapter 2010-138, L.O.F., effective January 2, 2011; and (3) provide that the governmental entity is prohibited from transferring the liability for tax, penalty, and interest to another party by contract or agreement.

Click here for the format of the Certificate of Entitlement to be issued by the governmental entity, as provided by the amended Rule 12A-1.094(4)(c)4., F.A.C.

The amended Rule 12A-1.094, F.A.C., is effective January 12, 2011.
