Three different utility excavation projects utilize one shoring system: an Efficiency Production

Manufactured Slide Rail System By James McRay

The old adage "one size fits all," normally does not apply to important trench safety equipment like trench shields and shoring. However, for three North Florida, South Carolina, and Alabama contractors, a more applicable adage would be, "one shoring system fits all sizes."

Recently, North Florida-based Watson Construction LLC, South Carolinabased Terry R Lee Contracting, and Alabama-based BallCon, Inc., completed projects in Gainesville, Florida; Hardeeville, South Carolina; an Mobile, Alabama respectively. All three underground utility installation projects were very different from each other-a gas tank, a lift station, affluent pumpsyet the trio of projects did have one thing in common; they all used an Efficiency Production manufactured Slide Rail Shoring System rented and delivered from Efficiency Shoring & Supply in Jacksonville, Florida.

Efficiency's Universal Slide Rail is a component shoring system comprised of steel panels (similar to trench shield sidewalls) and vertical steel posts. The highly versatile system can be used in a variety of configurations. Efficiency's Slide Rail System can be configured into small four-sided pits; an obstruction-free ClearSpan[™] configuration; or in a Multi-Bay[™] configuration to install large tanks and structures or lengths of pipe over 40 ft.

With Efficiency's Slide Rail, Watson Construction earns LEED Platinum rating

This past December at the University of Florida's Institute on Aging in Gainesville, Watson Construction installed a 36 foot long, 10 foot tall fiberglass collection tank. The project was slated as a LEED Platinum rated facility and the rainwater collection and reuse system was an integral part of achieving the Platinum rating.

The tank was installed at a moderate depth of 15 feet; however depth wasn't the primary challenge for Watson. The big challenge was contending with the surrounding structures, as the excavation site was crammed into the main building's courtyard and had only limited access on three sides of the long pit.

"One of the biggest advantages of Efficiency's Slide Rail System is the fact it can be installed with very limited access to the worksite," said Mike Hemenway, Efficiency Shoring & Supply's Jacksonville Branch Manager. "And the system can usually be installed with a standard sized excavator that many excavation contractors already have in their fleet; another advantage over other shoring system."

"After careful consideration of the constraints of installing the tank such as the tank's length and the depth of the pit, plus the limited space, we chose the Slide Rail System by Efficiency Production," said Steve Miller, Watson's Assistant Operations Manager. "It was almost a no brainer considering our past experiences with using the Efficiency system," Watson added.

Slide Rail is considered "positive shoring." It is installed by sliding the panels into integrated rails on the posts, and then pushing the panels and posts incrementally down to grade as the pit is dug; a process commonly referred to as a "dig and push" shoring system. "That's another advantage of our Slide Rail; there's no over-excavation," added Hemenway. "The system keeps constant pressure against the surrounding dirt, which was critical for Watson digging so close to that tall building," Hemenway concluded.

With the help of Efficiency Shoring's onsite installation team, Watson installed a 10 foot wide, 41 foot long, 16 feet deep; two-bay, 4-Sided Multi-Bay[™] configured Slide Rail System. Multi-

Bay[™] utilizes Efficiency's exclusive Parallel Beams that roll up and down the slotted rail on the inside face of the linear posts and have spreader collars like trench shield sidewalls—which pin standard trench box spreaders.

For the Watson project, tie-back waler i-beams were added at the top of the system, attach into integrated waler brackets that connect into a slotted rail on the outside face of the linear posts. Paired with a sacrificial member (such as a spreader pipe or timber beam) braced cross-trench against the bottom of the linear posts; the entire parallel beam spreader assembly can be completely removed which provided Watson a full 40 feet of open space to install the 36 foot long tank.

"The Slide Rail System proved efficient, effective, and easy to use," said Watson's Project Foreman, James Tilley. "I had never used a Slide Rail System before, but with help from the guys at Efficiency Shoring, it was as easy as any conventional trench box I've ever used, if not easier in this particular application," Tilley said.

Terry R Lee Contracting installs lift station in tight spot with Slide Rail System

About 150 miles north of Jacksonville in the little town of Hardeeville, South Carolina; Terry R Lee Contracting was utilizing an Efficiency Slide Rail System on the Old Charleston CDBG Sewer Upgrade project for the Beaufort Jasper Water & Sewer Authority. However, Lee's Slide Rail System was configured into a simple16 x 16 x 20 foot 4-Sided Pit configuration, which shored the excavation for Lee to install a pre-cast 6 foot diameter, 20 foot tall round lift station.

Though location and other project factors may change, excavation shoring challenges tend to run in patterns such as dealing with surrounding structures and other environmental issues. "We were digging in a residential area so we had very little space; really only access on two sides of the pit," explained Project Manager Bobby Lee. "We knew Slide Rail would be the best choice for the conditions; we've used (another manufacture's) system before. However we were convinced to try an Efficiency Production Slide Rail System now that they have a close dealership," Lee said, referring to Efficiency Shoring & Supply's Jacksonville Branch.

To help install the system, Efficiency Production sent their Special Operations Shoring Division's Senior Slide Rail Installer, Tim Hurst, to assist Lee with the installation. "The Lee guys were great to work with; super hard working," said Hurst. "They were able to get the entire system installed in a little over five hours which is great time for a system that size."

BallCon, Inc. and HCL Contracting use Slide Rail for pump install in congested WWTP

Mobile, Alabama, was the next location featuring a Slide Rail Systemshored excavation project. Mobilebased General Contractor BallCon, Inc. was the low-bidder to install an effluent pump station at the Wright Smith Jr. Waste Water Treatment Plant; one part of an overall project to upgrade the municipal WWTP.

Staying true to form, BallCon chose Efficiency's Slide Rail System in part for its ease of installation in a tight, congested spot. The $20 \times 40 \times 20$ foot deep excavation needed to be dug

and shored in and around the treatment plant's operational structures.

There were two other reasons Ball-Con chose an Efficiency Slide Rail System. The first, "It was less expensive than sheet piling and every bit as efficient," said BallCon's Richard Ball. Secondly, "We had great communications with (Shoring & Shielding Specialist) Ryan Nalls at Efficiency Shoring. We'd never used Slide Rail before but because of the help from Ryan, we'd use it again," Ball said.

The excavation, shoring, and pump installation was performed by subcontractor HCL Contracting, also based in Mobile.

We recently launched the "Report Unlicensed Activity" function now available on the free DBPR Mobile app. The new function allows consumers to report unlicensed activity in real time. In a world of instant communication and technology, the new app function provides another avenue for the public to directly communicate with us at DBPR.

Unlicensed activity occurs when someone represents themselves as a licensed professional or provides services that only licensed professionals can perform. When a person misrepresents themselves as having a professional license to do specialized work like an electrical contractor, roofer or realtor, DBPR has an active role in taking action against those individuals. Unlicensed activity is against the law, and this new app function allows Floridians to instantly report concerns to DBPR.

Consumers can submit complaints of unlicensed activity with descriptions and pictures directly from mobile devices, and the information is received almost instantaneously by DBPR. To learn more about how to use the new app function to report unlicensed activity, you can watch a tutorial on the DBPR YouTube channel. Also, if you have not already downloaded the free DBPR Mobile app, it is available on the iTunes and Google Play app stores.

From air conditioning contractors to cosmetologists, consumer reports of unlicensed activity aid the Division of Regulation in carrying out more well-organized and successful sting operations. This fiscal year, DBPR has already conducted 18 stings throughout Florida.

It is our hope that this new app function will help streamline the process for both consumers and DBPR to handle unlicensed activity complaints and questions. As we work to bring unlicensed individuals into compliance with the law, this is just one more tool the department offers to better serve licensees and consumers.

Don't Fall For This Little Known Lien Trap

On its face, Florida's Lien Law is simple. A contractor that provides labor and material that improves real property is entitled to use a lien to make sure the contractor gets paid. However, the lien law actually is far from simple. In fact, it has become a morass of confusing terms, exclusions, and exceptions that can be a trap for the uninformed. This month we'll discuss a little known trap that could cost you money if you are not aware of it.

But first, we must set the table with some lien law basics.

A lien is merely a form of security for a debt owed under a contract. Think of a lien as the equivalent of a mortgage on your house. When you borrowed money from a bank to buy a house, you gave the bank a promissory note where you promised to pay the loan back and to secure that debt you allowed the bank to place a mortgage on your home. If you fail to pay back the loan as promised, the bank can foreclose its mortgage, sell your house and use the sale proceeds to pay off your home loan. A mortgage is usually placed on the property simultaneously when the debt is incurred, i.e. you give the mortgage when the loan is made.

Similarly, a lien is the security a contractor is allowed to place on real property that is improved by the contractor. The lien makes sure the property owner pays the contractor for the contractor's work as promised. If the property owner fails to pay as promised, the contractor can file a lien, foreclose the lien, sell the property, and use the proceeds to pay off the owner's debt. A lien is typically placed on the property after the work has been done and after the debt has been incurred.

Typically the following claimants in the project food chain may lien:

- Contractors (has a contract with the property owner);
- Subcontractors (has a contract with the contractor);
- Sub-subcontractors (has a contract with a subcontractor);
- Material suppliers to contractors, to subcontractors, or to sub-subcontractors; and
- Laborers.

There are other types of lienors, but these are the lienors that typically are encountered.

There are several different notice provisions which may or may not apply depending on where the lienor is in the food chain. However, one requirement that "everyone" knows about is that a lienor has to record the formal claim of lien in the county records within 90 days of the lienor's last work on the property.

The lien law which is written by lawyers is a lot more complex than this (which is why lawyers are able to afford fancy ties), but this is the basic framework.

And now, we'll expose this month's lien trap.

If work on a project is terminated before the work is completed, say for example, the owner fires the contractor or the contractor abandons the work because the owner has failed to pay, then the time to record the lien can be 30 days from the contractor's last work, instead of 90 days. The time can be shortened to 30 days if, after a premature termination, the owner files and serves an "Affidavit of Recommencement" stating the owner's intent to recommence the work. Florida Statute, Section 713.07(4) states that if an Affidavit of Recommencement is filed and served on the potential lienors that performed work prior to the termination, then those lienors must record their liens within 30 days of the filing and service of the Affidavit of Recommencement. If the lien is not timely filed, then the lien is lost.

Thus, if you are involved in a project that is terminated prematurely, make sure your staff is aware of this potential trap and that they act immediately if an Affidavit of Recommencement is received.
