CONTRACTOR [☐] A contractor is any person, firm or corporation actively engaged as an underground utility contractor in the construction and/or rehabilitation of utility systems including, but not limited to, storm sewers, sanitary sewers and drainage systems, water lines, cables, ducts, conduits, gas lines, tunneling, boring, trenchless construction, treatment systems, pump stations and all other utility construction and appurtenances thereof.

ASSOCIATE [☐] Any person, firm or corporation that provides equipment, material or services to the underground utility industry who are actively engaged as utility contractors as described in the "Contractor" category.

AFFILIATE [☐] Any person, firm or corporation that serves the underground utility industry but not as their sole purpose of business such as surety, accounting, consulting or privately owned utility companies.

The Omnibus Budget Reconciliation Act of 1993 includes a provision which denies the tax deductibility of lobbying expenses and introduced new rules affecting tax-exempt organizations that conduct lobbying and political activities.
