JANUARY LEGISLATIVE REPORT

SUNNY SKIES FOR INAUGURAL

On January 7th, on the east side of the Old Capitol Building under sunny skies, Florida's 46th governor, lieutenant governor and new cabinet members were all ceremonially sworn into office. Governor Ron DeSantis took the oath of office along with Lieutenant Governor Jeanette Nunez and cabinet members Ashley Moody, Attorney General; Jimmy Patronis, Chief Financial Officer, State Treasurer & State Fire Marshal; and the lone statewide office Democrat, Nikki Fried, Agriculture Commissioner. DeSantis pledged to keep Florida a low-tax state, to improve water quality and to end "judicial activism."

WATER POLICY, SEPTIC TANK CONVERSIONS GETS NEW GOVERNOR'S ATTENTION

Wasting little time, Florida's new Governor Ron DeSantis issued an Executive Order addressing several environmental issues (see full order below). DeSantis' order calls for \$2.5 billion over the next four years for Everglades restoration and water resource protection --- a \$1 billion increase over what was spent the prior four years --- as well as creation of the Office of Environmental Accountability and Transparency and the Office of Resilience and Coastal Protection, both within the Department of Environmental Protection. On the issue of septic tanks, the Governor's Executive Order directs the Department of Environmental Protection to establish a septic-to sewer grant conversion grant program, where local governments would have to put up money but then the state would match it.

The governor also instructed the South Florida Water Management District to "immediately" start the next phase of the reservoir project south of Lake Okeechobee and to work with the U.S. Army Corps of Engineers to keep the project on schedule.

GOVERNOR RON DESANTIS ANNOUNCES MAJOR WATER POLICY REFORMS

Governor Ron DeSantis signed Executive Order 19-12 (Achieving More Now For Florida's Environment), implementing major reforms to ensure the protection of Florida's environment and water quality.

"Our water and natural resources are the foundation of our economy and our way of life in Florida," said Governor Ron DeSantis. "The protection of water resources is one of the most pressing issues facing our state. That's why today I'm taking immediate action to combat the threats which have devastated our local economies and threatened the health of our communities."

The order calls for:

- \$2.5 Billion over the next four years for Everglades restoration and protection of water resources (a \$1 Billion increase in spending over the previous four years and the highest level of funding for restoration in Florida's history).
- The Establishment of a Blue-Green Algae Task

Force, charged with focusing on expediting progress toward reducing the adverse impacts of blue-green algae blooms now and over the next five years.

- Instruction to the South Florida Water Management District to immediately start the next phase of the Everglades Agricultural Area Storage Reservoir Project design and ensure the U.S. Army Corps of Engineers approves the project according to schedule.
- The Creation of the Office of Environmental Accountability and Transparency charged with organizing and directing integrated scientific research and analysis to ensure that all agency actions are aligned with key environmental priorities.
- The Appointment of a Chief Science Officer to coordinate and prioritize scientific data, research, monitoring and analysis needs to ensure alignment with current and emerging environmental concerns most pressing to Floridians.

EXECUTIVE ORDER 19-12: ACHIEVING MORE NOW FOR FLORIDA'S ENVIRONMENT

Section 1: Focus on Rapid Improvement for Water Quality, Quantity and Supply


I hereby direct the Department of Environmental Protection (DEP), the Department of Health (DOH) as provided in paragraph J below, and Visit Florida and the Department of Economic Opportunity (DEO) as provided in paragraph L below, to take the following actions to enhance Florida's water quality and preserve its natural resources:

- A. Secure \$2.5 billion over the next four years to invest in Everglades restoration and protecting our water resources.
- B. Establish a Blue-Green Algae Task Force, charged with focusing on expediting progress toward reducing the adverse impacts of bluegreen algae blooms now and over the next five years. This task force should support key

funding and restoration initiatives to expedite nutrient reductions in Lake Okeechobee and the downstream estuaries. This task force should identify priority projects for funding that are based on scientific-data and build upon Basin Management Action Plans to provide the largest and most meaningful nutrient reductions in key waterbodies, as well as make recommendations for regulatory changes.

C. Update and secure all restoration plans, within one year, for waterbodies impacting South Florida communities, including Lake Okeechobee and the Caloosahatchee and St. Lucie Estuaries. These updates will ensure that the Blue-Green Algae Task Force has the necessary information to provide guidance to DEP on maximizing the investments in water quality improvements.

- D. Instruct the South Florida Water Management District to immediately start the next phase of the Everglades Agricultural Area Storage Reservoir Project design and ensure the U.S. Army Corps of Engineers approves the project according to schedule.
- E. Expedite key Everglades projects including the C-44 reservoir and stormwater treatment area, C-43 reservoir, Tamiami Trail and additional projects necessary to protect our waterways and natural resources.
- F. Workwith the South Florida Water Management District to add stormwater treatment to the C-43 Reservoir to provide additional treatment and improve the quality of water leaving this important storage component.
- G. Expedite projects with the U.S. Army Corps of Engineers to improve management of Lake Okeechobee, including updating the Lake Okeechobee Regulation Schedule and identifying water quality treatment technologies to install near water control structures in Lake Okeechobee.
- H. Direct DEP to establish a septic conversion and remediation grant program with a local government match requirement.
- I. Instruct all five water management districts to increase transparency and accountability by providing data and information to DEP to support key water quality restoration efforts. Instruct all water management districts to review budgets and prioritize available funding to focus on projects that will help address harmful algae blooms and maximize nutrient reductions.
- J. Participate in Florida Fish and Wildlife Conservation Commission's (FWC) Harmful Algal Bloom Task Force to provide technical expertise and assistance studying causes and impacts of red tide. The DOH is also directed to participate in FWC's Task Force to help study air quality and human health impacts of red tide.

- K. Continue DEP's red tide emergency grant program to support local governments to clean up their beaches and coastal areas to minimize the impacts of red tide to residents and visitors.
- L. Partner with Visit Florida and DEO to identify opportunities within communities and recommend investments in green infrastructure, such as wetland treatment systems, that benefit our natural resources and local economies by increasing recreational and tourism opportunities, while improving water quality.
- M. Engage local governments, industry, universities and water management districts to identify and research all viable alternative water supply sources and provide an assessment of funding needs critical to supporting Florida's growing economy. DEP should take all necessary steps to establish recurring funding for an alternative water supply grant program to help communities plan for and implement vital conservation, reuse and other alternative water supply projects.
- N. Engage local governments, industry, citizens and other stakeholders through a targeted education and outreach campaign that will focus on the importance of conservation and reuse efforts and encourage Floridians to implement essential conservation and reuse efforts in their homes, businesses and communities throughout Florida.
- O. Continue to explore every option to stop Georgia's harmful upstream water use from causing further adverse impacts to the Apalachicola River and Bay.

Section 2: Restructuring to Focus on Accountability, Transparency, and Science to Achieve More Now for Florida's Environment

I hereby direct DEP to implement the following actions to ensure the agency is making sound decisions based on the best available science and providing for accountability and transparency:

- A. CreatetheOfficeofEnvironmentalAccountability and Transparency charged with organizing and directing integrated scientific research and analysis to ensure that all agency actions are aligned with key environmental priorities.
- B. Appoint a Chief Science Officer to coordinate and prioritize scientific data, research, monitoring and analysis needs to ensure alignment with current and emerging environmental concerns most pressing to Floridians.
- C. Take all necessary actions to move the Environmental Crimes Enforcement Unit from FWC to DEP to align resources focused on environmental protection and ensure strong enforcement of Florida's environmental laws.

Section 3: Ensure Florida's Valuable and Vulnerable Coastlines and Natural Resources are Protected

I hereby direct DEP to implement the following actions to protect Florida's coastlines and natural resources:

- A. Create the Office of Resilience and Coastal Protection to help prepare Florida's coastal communities and habitats for impacts from sea level rise by providing funding, technical assistance and coordination among state, regional and local entities.
- B. Take necessary actions to adamantly oppose all off-shore oil and gas activities off every coast in Florida and hydraulic fracturing in Florida.

RPOF GETS NEW LEADER

State Sen. Joe Gruters of Sarasota was chosen January 12 to lead the Republican Party of Florida. Gruters, who defeated Charlotte County State Committeeman Bob Starr in a 192-25 vote at the party's annual meeting in Orlando, will replace Blaise Ingoglia, a House member from Spring Hill who has served as chairman of the state party since 2015.

In a statement released after the vote, Gruters said he will work with county party officials and local elected officials heading into the 2020 elections, as President Donald Trump is expected to run for a second term.

SCIENCE EXPLAINS WHY PRODUCTIVITY HACKS AND RESOLUTIONS ARE PRACTICALLY DESTINED TO FAIL

Spoiler alert: Very few of them actually work. Here's why.

As we approach the new year, the inevitable flurry of self-management tips beckons. It's a pity that they are so hard to implement, but this actually explains their proliferation. If there is so much demand for suggestions on how to fix one's bad habits and replace them with brand-new, effective behaviors, it's precisely because very few suggestions actually work.

Consider that 80% of New Year's resolutions are broken within two months-and these tend to concern habits or behaviors we are actually determined to change. So much so that they are often recycled year after year. Think, then, how much harder it is to find the will and persistence to change things just in order to please other people, like a boss, spouse, or client.

So, why are significant changes to our habits so hard to attain? Psychology provides some useful answers:

First, there is a big difference between wanting change and wanting to change. Even when people

profess a clear desire to change, what that usually means is that they are interested in change as an outcome rather than change as a process. In other words, most people don't really want to change, they want to have changed.

For instance, when someone says they want to lose weight, what they usually mean is that they want to have lost weight, without the dreadful stoic sacrifices that that would entail. Same for when someone says they would love to learn to speak Japanese or quit smoking.

Another way to look at this is that we probably don't care as much about changing as we say, or we would not be put off by the prospect of doing what we need to do to achieve that change. This may sound defeating but it's a more honest depiction of our motivation than we have when we pretend to want something we don't really want. Acknowledging this fact would minimize guilt while refocusing our energies on the things we actually value more than the triggers of change: e.g., free time, sleeping, pleasure, eating, and smoking.

Second, our personality constrains our ability to change, setting the limits to our likelihood of replacing old habits with new ones. As large-scale scientific studies have shown, our predispositions don't change much. This is why we are rarely surprised when we meet people we have not seen in 10 or 20 years, like at high school reunions. Their physical appearance may have changedsometimes dramatically-but their attitudes, style, and values tend to remain pretty fixed.

This is not to say that people can't change, but they either become exaggerated versions of their earlier selves, or follow a common maturity curve that makes them less open to new experiences, more conservative, and more conscientious (think: becoming more boring versions of ourselves).

For all the hype about grit and growth mindset as catalysts of change, there is little scientific evidence to show that we can actually boost people's grit or growth mindset beyond their personal default level. Rather, these qualities behave much like other personality traits, so they are found in different degrees in different people. Paradoxically, a growth mindset is more fixed than dynamic.

Last, but not least, we all strive to make our environments as predictable and unthreatening as possible. The mere thought of change is threatening and frightening, which is why we gravitate toward the familiar and are generally happier with the devil we know. This may sound counterintuitive in an age that glorifies disruptive rule breakers with no tolerance for boredom and routine, but it is still the reality for most people. And that's okay. Life is complex enough to abandon the possibility of controlling and managing some of its elements, and the more predictable most things are, the more freedom we have to pursue innovation and change in others.

However, there is also a cost to this. We become increasingly programmed to behave in more similar ways, and our growing ability to adapt to environments decreases our ability (and willingness) to change. The psychological term for this is niche-picking, and it speaks to a reciprocal relationship between our habits and the challenges and problems that benefit from them.

Sociable people will seek social situations where their ability to interact with others is a natural adaptation. These situations will in turn reward and enhance their sociability. This creates a snowball effect that makes it less and less appealing (and adaptive) for them to spend time on their own. By the same token, people who are naturally more introverted will tend to avoid situations of rich social interaction, preferring instead to spend time on their own (reading, thinking, watching movies). This, in turn, will enhance their ability to adapt to solitary environments while reducing their ability to interact with strangers. Because these mechanisms are in place from a very early age, the longer we wait to try to break these cycles, the harder it is to break them.

Changing and becoming a better version of ourselves is possible. But that change is going to be hardest when we are not truly committed and when it involves going against our nature. A hack

> that promises to help us can't when it depends on us having to unlearn our deep-rooted patterns of adapting. That's why playing to our strengths is much easier, to the point of not requiring much effort at all. It's a bit like being asked to start next year by being ourselves.


PANHANDLE COMMUNITIES MAY BENEFIT FROM LAND ACQUISITION TRUST FUND

A bill recently introduced by Sen. Bill Montford (D-Tallahassee) would designate at least \$50 million a year from the Land Acquisition Trust Fund to 14 Panhandle counties that sustained damage last October from Hurricane Michael. The trust fund receives money under a 2014 constitutional amendment that mandates setting aside a portion of documentary-stamp taxes for land and water conservation. Last week, Gov. Ron DeSantis directed the state Division of Emergency Management to expedite funds to Panhandle communities swamped financially by "massive" amounts of debris from Hurricane Michael.

Under Senator Montford's initiative (SB 376), the Department of Environmental Protection would be able to use trust-fund money for reforestation, ecosystem management, fire control measures, debris removal, beach renourishment, coastal protections and wastewater treatment facilities. Should the measure make it through the legislative process, funds would be designated to the region annually for seven years. The state already uses portions of the trust fund for such things as Everglades restoration, Lake Apopka restoration, the construction of a reservoir in the Everglades Agricultural Area and springs restoration.

FLORIDA MINIMUM WAGE SET FOR INCREASE

PROJECT SCOPE

The project consists of the development of 211 single family and multi family lots for a residential subdivision in San Antonio, FL. The type of work is not out of the ordinary but some of the means and methods to perform the work were. On multiple phases of the projects we had to lay sanitary sewer of depths up to 22' below existing ground. Laying 20'+ deep sewer is a challenge but what made the project even more challenging was the fact that all of the Clay soils encountered in the pipe trenches were deemed unsuitable to remain under the roadway per County specifications. We had to use double stacked trench boxes in order to operate safely in the 20' trenches. Our goal was to keep the pipe trench as narrow as possibly but within OSHA compliance. Any clay soils that we did not disturb were allowed to remain in place. Anything that was excavated could not be placed back under the roadway.






